NBCL a leading fertilizer manufacturer with four manufacturing plants near Ahmedabad, invites tenders from reputed and experienced transporters for the transportation of all types of fertilisers from NBCL Unit 1,2,3 & 4 to various destinations across Gujarat, Maharashtra, Madhya Pradesh, Punjab, Rajasthan, Telangana, Karnataka, Andhra Pradesh, and Uttar Pradesh. More information about NBCL is available at www.nbclindia.com. NBCL is in the process of appointing Transport Contractors for movement of all types of Fertilisers in Trucks from NBCL Plants, Gujarat to various destination in different States, across the Country. The details in respect of the proposed Tender are furnished hereunder.

1. SCOPE OF WORK

- 1.01 The scope of services to be rendered by the successful Bidder(s) against this Tender Enquiry shall be the transportation of all Fertilisers which are packed in 25kg / 50kg bags, by Trucks from NBCL manufacturing units 1,2,3 & 4 (**Refer annexure-D for Plant address**) to various destinations across Gujarat, Maharashtra, Madhya Pradesh, Punjab, Rajasthan, Telangana, Karnataka, Andhra Pradesh, and Uttar Pradesh.
- 1.02 The Contractor / Bidder must have been registered under 'Goods Transport Agency' (GTA) Category for GST Purposes.
- 1.03 The Contractor shall be responsible for the Fertilizers handed over to him for Transportation, from the time the bags are loaded into the Truck, till it reaches the final destination / Delivery point and delivered in good condition to the Consignee(s). On delivery of material at the designated delivery point, the Contractor shall obtain an acknowledgement duly signed and stamped by the Receiving Party/ or its Authorized Representative.
- 1.04 **The scope of Services shall include generation of the required E-Way Bill before the Trucks are loaded / dispatched from NBCL Plants.** The scope of Services will also include taking transit risk insurance cover for the material up to the specified destinations of NBCL. The Contractor / Transporter shall ensure that while the Trucks are in Transit, all required documents including E-Way Bill remain valid and are readily available with the Truck Driver, for inspection enroute, by the concerned Authorities. In case, any necessity of revalidation/ Extension of E-Way Bills already issued from NBCL plants arises, the Transport Contractor shall ensure that such requirements are immediately complied with / communicated to the originating Point for revalidation. It shall be the responsibility of the Bidder to ensure that all statutory requirements on the vehicles being used for execution of this Contract are duly complied, including comprehensive insurance on vehicles and Road tax and other taxes whatsoever in nature, if any, on inter state movement of trucks etc. No increase in rates would be permissible in the event of increase in such charges.

- 1.05 **Rates are to be quoted in Indian Rupees on Per Metric Ton / destination basis.**
- 1.06 **Truck Load-wise Rate Submission Clause:** The transporter is required to submit separate freight rates for the following truck load categories:
1. **20–25 MT truck load**
 2. **25–30 MT truck load**
 3. **30–40 MT truck load**
 4. **Above 40 MT truck load**

The rates must be clearly mentioned for each category, and the transporter shall be bound to provide vehicles accordingly, based on the load specifications communicated by the company. Failure to quote or supply as per the specified load categories may lead to disqualification or rejection of the bid.

- 1.07 Bidders are required to go through the documents thoroughly and ensure that the submission of Bids are strictly as per the terms of this Tender Enquiry.
- 1.08 Bidders may quote their best rates for road Transportation for all the States mentioned in the attached **Annexure-B**. Please note that Bidders are required to quote separate Rs/MT/Destination to be applicable for each State, district-wise.
- 1.09 **Inter-Plant Loading:** The bidder/transporter shall be required to undertake loading not only from the designated primary plant but also from other manufacturing units/plants of Narmada Bio Chem Limited (NBCL), as and when instructed by NBCL, for the purpose of inter-plant transfer or for delivery to the final destination.

For Example: - It may happen that part of the cargo is to be loaded from NBCL Unit-1 and the remaining part from NBCL Unit-4, or from any other NBCL plant as per operational requirements. The transporter must ensure proper coordination and arrangement of vehicles accordingly to complete such split loading in a timely and efficient manner.

The rates quoted by the transporter shall be inclusive of such inter-plant loading operations unless specified otherwise. No additional claims shall be entertained on account of such loading arrangements.

Failure to comply with inter-plant loading instructions may lead to penalties and/or disqualification from the contract.

1.10 **Multi-Delivery Consignments:** The transporter may also be required to deliver a single consignment to multiple delivery destinations (multi-drop deliveries) within same district/same state. It shall be the transporter's responsibility to ensure accurate and timely deliveries as per the consignment instructions and delivery challans issued by NBCL.

1.11 In case of consignments requiring delivery at multiple destinations within the same district or state under a single indent, the Contractor shall be entitled to an additional payment of **Rs. 50/- (Rupees Fifty only) per Metric Ton for per additional delivery** , over and above the approved freight rates. This additional charge shall be applicable towards compensation for the extra handling and logistical efforts involved in executing multi-point deliveries.

1.12 **Goods Integrity:** It shall be the sole responsibility of the transporter to ensure that the goods are delivered in the same condition as loaded at the plant. Any loss, damage, spillage, pilferage, or deterioration in packaging during transit shall be liable to be recovered from the transporter as per NBCL's policy and applicable penalty clauses.

1.13 **Vehicle deployment** - Upon receipt of the dispatch advice, the transporter must ensure vehicle placement within 24 (twenty-four) hours. In the event of failure to lift the advised quantity within the stipulated time, a penalty of ₹100 (Rupees One Hundred) per Metric Ton per day/per vehicle shall be applicable for the delayed quantity. This penalty shall be recovered from the transporter's invoice or adjusted against any payments due from NBCL.

2. TENURE & QUANTITY:

2.01 The tenure of this proposed Contract will be for a period of 12 (Twelve) months from the date of award of Contract, with a provision to extend the same for a further period of 3 (three) months at NBCL's option. Notwithstanding the same, the tenure of the Contract could be



extended further, on mutually agreed rates, terms and conditions.

- 2.02 The details of State-wise total quantity of all types of Fertilisers, likely to be handled during the Contract period will be as mentioned in **Annexure C**. The Quantities have been estimated on a tentative basis and hence may vary at the time of award of Order. Once the Contract is awarded, the Contractor shall be obliged to undertake the Transportation Services on the terms and conditions laid down in the NIT/ Work Order and the rates determined therein shall remain firm during the entire period of Contract including any extension thereof, except for the escalation as may be specifically spelt out therein.
- 2.03 The Quantities mentioned in **Annexure C** are on estimation basis. Even if the actual quantity moved to any State being lower than the original estimation, the Contractor shall not be entitled to any compensation whatsoever. The Payment to the Contractor shall be based on the actual quantity (weight) transported, which may please be noted.
- 2.04 During the tenure of the contract, the Contractor will not stop the work at any stage under any circumstances whatsoever. The Contractor will have to take all required steps to prevent any loss and / or damage / theft / pilferage of whatsoever nature, to the Consignment received by him from NBCL during the period the same is in his charge i.e. till it is delivered to the Consignee(s) at the specified delivery point / location.
- 2.05 However, in case of delay in transshipment beyond reasonable period, a penalty of Rs. 500/- plus GST, per truck will be imposed. Only in case of accident the penalty will be waived on submission of sufficient proof of accident i.e. FIR lodged etc. with the approval of competent authority.

3.00 ELIGIBILITY CRITERIA & PROCEDURE / LAST DATE FOR SUBMISSION OF BIDS:

3.01 ELIGIBILITY CRITERIA:

The Bidders who meet the following experience / performance criteria shall only be eligible for bidding:

Transporter / Contractor having experience of transporting minimum 25,000 mt of any dry

material during one year or have executed transportation contract for a minimum value of Rs. 25 lakh in a single order in a year or parts thereof, during the last five years may only submit their application.

Bidders shall submit necessary proofs in support of meeting the above eligibility criteria as asked for in the Technical questionnaire attached in **Annexure A**. Bids of the bidders not meeting the above criteria shall not be considered and shall be rejected outrightly.

3.02 The Bidders willing to transport NBCL Fertilisers Bags, are required to submit their Bids against this enquiry in **three separate sealed envelopes as per details below :-**

a) **Envelope-I** superscribed as **'EMD for Transportation of all types of Fertiliser'** should contain the requisite Earnest Money Deposit (EMD) of Rs. 50,000/- by way of Demand draft/ Banker's cheque /NEFT/ RTGS along with a Certificate that all the terms & conditions of the tender are acceptable to the vendor. In case of non-confirmation of EMD amount by the Bank, the bids of the concerned party shall not be opened and rejected outrightly.

Any other information which the Bidder wishes to intimate as testimony to his Performance track record, Credentials, etc., may also be included in the Technical Bid envelope. - c) **Envelope-III superscribed as 'Price Bid for Transportation of all types Fertiliser' as per the Rate Format at Annexure B.**
- d) **All the above three separately sealed envelopes, put together in a bigger ENVELOPE addressed to Head - logistics, Narmada House, Plot No. 252, T.P. No. 50, Opp Mantavya News, Sindhu Bhavan Road, Off S. G. Highway, Thaltej, Bodakdev, Ahmedabad, Gujarat 380059, should be submitted physically at the above address through Courier/ Speed Post/ in person on or before 10.05.2025. Bids sent through email shall not be accepted and shall be rejected outright.**
- 3.03 All the documents to be submitted as mentioned above shall be duly stamped and signed by the Authorised person of the Bidder / Contractor.
- 3.04 Bids without the requisite self-certification by the Bidder confirming acceptance of NBCL's Tender terms & conditions, would be rejected outright and will not be considered further.
- 3.05 At the time of submission of bids, the bidders shall furnish a self-declaration that they have not been banned or de-listed by any Govt. Dept./ Financial Institution/ Cooperative Institution/ court etc
- 3.06 The Earnest Money Deposit (EMD) envelope should not be put in Price Bid Envelope.
- 3.07 The EMD paid / submitted along with the tender will earn no interest and the same will be refunded to unsuccessful bidders after the award of the job to the successful bidder. For the successful bidders, the EMD paid shall be adjusted in the security deposit required to be provided on successful award of the contract as per clause 16.0.
- 3.08 Price Bids are to be submitted duly stamped and signed by the Bidder / Contractor. The quoted rates should be all inclusive and strictly as per Rate Format attached herewith at **Annexure – B**. Taxes if any, should be mention separately.
- 3.09 **Tender Registration Fee :-All interested bidders are required to pay a non-refundable tender registration fee of ₹5,000/- (Rupees Five Thousand only) for participating in**

The registration fee must be submitted **through a Demand Draft (DD)** drawn in favor of **Narmada Bio Chem Limited** payable at **Ahmedabad**.

- The Demand Draft must be issued **by a scheduled bank after the date of publication of this tender advertisement**.
- The DD should be **valid for a minimum period of 60 days** from the date of submission of the bid.
- The DD should be submitted along with the EMD in Envelope I.
- Bids submitted without the required DD for the registration fee shall be treated as **invalid and will not be considered for evaluation**.

4.0 DATE OF SUBMISSION, OPENING AND EVALUATION OF BIDS:

4.01 The bids addressed to Head – Logistics, Narmada House, Plot No. 252, T.P. No. 50, Opp Mantavya News, Sindhu Bhavan Road, Off S. G. Highway, Thaltej, Bodakdev, Ahmedabad, Gujarat 380059, must be submitted latest by 1900 Hrs on **16.05.2025** through Courier / Speed Post / in person to Logistic Head, at 4th Floor, Narmada House, Plot No. 252, T.P. No. 50 Opp. Mantavya News, Sindhu Bhavan Road, Off S. G. Highway, Thaltej - Bodakdev, Ahmedabad - 380059, Gujarat (India).

4.02 The EMD envelopes (**Envelope-I**) will be opened first. Once the EMD is found to be in order, the Technical Bid envelope (Envelope-II) will be opened which will be scrutinized. After evaluation of the bids, if required, discussions will be carried out with the respective Bidder. Based on the discussions and clarifications on the Technical Bids, if required, the Bidder(s) shall submit their fresh Price Bids in sealed envelopes, duly incorporating the resultant increase / decrease in Price, if any.

4.03 To assist in the examination, evaluation and comparison of bids, NBCL may, at their discretion, ask the Bidder for any clarification of Technical Bid and may open the Price Bid (**Envelope-III**) later on, i.e. on a separate date, which will be intimated by NBCL through

- 4.04 NBCL shall have the right to place the Order(s) / award the Work to more than one Party for any / all States, at its sole discretion.
- 4.05 NBCL would be awarding separate Road Transportation Contracts for each State. For the purpose, the 'Lowest Bidder' for each State would be identified separately. The Rates are to be quoted exclusive of GST, as NBCL being the Service Recipient, would be remitting the GST at the applicable rates to the concerned Department on 'Reverse Charge' basis. NBCL may negotiate the Rates with the Bidders, if deemed necessary.
- 4.06 NBCL reserves the right to accept or reject at its sole and absolute discretion, any/all bids in whole or in part, and / or accept other than the lowest bid without assigning any reasons whatsoever. The award of order(s) shall be at NBCL's sole and absolute discretion and shall not be subject to any dispute/protest by any of the party(s).
- 4.07 Notwithstanding anything to the contrary contained herein, NBCL reserves the right to accept or reject any bid, and to annul the bidding process and reject all bids, at any time prior to award of Contract / Work order, without thereby incurring any liability to the affected bidder, or bidders, or of any obligation to inform the affected bidder, or bidders of the grounds for NBCL's action.

5.0 INSURANCE:

Comprehensive insurance cover of vehicle & NBCL's stock (for transit period) should be taken by the Contractor / Transporter at its own cost.

6.0 PAYMENT TERMS:

- 6.01 Transportation bills should be submitted to NBCL's concerned recipient State Office along with proper acknowledgement. No bills will be entertained unless the following conditions are fulfilled.

- a) Bills should be raised only after full execution of the Despatch Invoice/Stock Transfer Order/Delivery Challan irrespective of quantity. No bills will be entertained for partial Despatch Invoice/Delivery Challan executed.
 - b) All Bills to be raised by the Contractor shall specifically mention its GSTIN. It should also carry the GSTIN of concerned State Office of NBCL as the Service Recipient and submitted to the concerned State Office.
 - c) Payment shall be made after 30 (thirty) days from the date of receipt of bills, along with all requisite supporting documents, at the NBCL Head Office. The payment is subject to the Contractor uploading the corresponding Tax Invoices on the GST Portal as per applicable statutory requirements.
 - d) For removal of doubts, it is hereby clarified that no payment is admissible and payable to the Contractor other than the Transportation charges determined if any, actually incurred enroute by the contractor, while transporting NBCL Fertilisers to the destination.
 - e) Payment of the bills, complete in all respects with supporting documents, will normally be made to the Contractors after 30 days from the submission of the bills along with necessary acknowledgment of dispatch document duly signed by the receiving Party / Representative at the destination. The bills must be submitted complete in all respects within 30 days from the date of Dispatch Invoice/ Stock Transfer Order/ Delivery Challan.
- 6.02 Further, in the event of Contractor's delay in execution of Transportation or breach of any other terms of contract due to reasonable cause, the Contractor / Transporter must inform NBCL with justification within 30 days from the date of Contractor's invoice or date of completion of work whichever is earlier. In case no such request / justification is received by NBCL within the permissible time limit, it shall be presumed that the Contractor has no reasonable cause for delay and shall be held liable for the losses caused due to delay in execution / breach of contract. Necessary action shall be taken by NBCL authorities accordingly including any deductions / penalties as may be deemed fit.
- 6.03 Representations if any, on the matter of delay in execution of Transportation or breach any other terms of contract by the Contractor may be considered on its merit on a 'case to case' basis by NBCL. In case, the reasons for the default is not found justifiable, all the Recovery / Deductions mentioned in this Contract would be applicable. Such deductions would also

attract GST at the extant rate (currently 18%).

6.04 In the case of the termination of the Contract due to unsatisfactory performance, NBCL reserves the right to get the incomplete jobs done at the risk and cost of the Contractor and all such cost shall be recovered from the Contractor's bills or otherwise. The deductions / recoveries from the Contractor shall be for the following:

- i) Damages for delayed delivery of the Fertilisers at the Destination.
- ii) Compensation for shortage, damages, pilferage, loss of material or any other such account.
- iii) Any other payment made by the NBCL on behalf of the contractor.

6.05 NBCL reserves the right to terminate this contract without any liability, by giving 15 days written notice provided however it shall be obligatory on the part of the contractor to complete the contractual obligations during the period of such notice.

7.0 ACCIDENT LIABILITY:

7.01 The Contractor shall be liable for any damage / injury / loss caused to NBCL's employees or any other person or persons etc., due to negligence of the Contractor and / or his employees. Further, NBCL accepts no responsibility for any injury to any person, whether contractor's employee or otherwise, caused due to carriage of fertiliser by the Transporter.

8.0 DELAY/ FAILURE:

8.01 The Contractor shall deliver the material to the Consignee at the destination as per the instructions of the Consignor within 2 days from the date of dispatch if the destination is within the State of Gujarat. For other destinations, outside Gujarat State the transit time would be allowed based on average 400 Km/Day. NBCL is also entitled to recover such costs, damages, charges as may be necessary due to any delay in delivery/receipt of

acknowledgment. Penalty for delayed delivery beyond the normal transit time (based on average distance of 400 Km/ Day) will be Rs. 2000/- plus GST per day per Truck.

8.02 In case of damaged material received at the destination, the cost of damaged material shall be recovered from the transporter. The acknowledgement from the consignee on Dispatch Invoice/ Stock Transfer Order/ Delivery Challan should bear Consignee's stamp / seal along with signature of its Authorised representative. The acknowledgement from the Consignee on Dispatch Invoice/ Stock Transfer Order/ Delivery Challan mentioning the receipt of Qty., the date and time along with signature of its Authorised representative under their seal/stamp shall be submitted along with the bills to the concerned State Office of NBCL. No payment shall be released without the Dispatch Invoice/ Stock Transfer Order/ Delivery Challan duly acknowledged by the Consignee.

8.03 The Contractor shall be responsible for the goods against damage, shortage, deterioration, loss, pilferage etc. occurring for any reason whatsoever during the Transportation. The carrier shall keep NBCL fully indemnified on this behalf, cost of any shortage, loss deterioration or pilferage shall be recovered at the 150% of the MRP plus GST.

9.0 LIABILITY OF CLAIMS / INDEMNITY:

9.01 NBCL shall not be liable for payment of any claim arising out of or in consequence of negligence on the part of Contractor or any of his employees to any property belonging to third parties or the contractor or any accident involving Trucks and / or employees of the Contractor. It shall be the sole responsibility and liability of the contractor and he shall indemnify and keep NBCL indemnified against the same at all times.

9.02 Without prejudice to any other provisions contained herein, the Contactor shall be bound to keep NBCL or any representative or employee of NBCL, its properties and assets fully indemnified at all times notwithstanding the expiry of the terms or termination of the Contract against any action claim or proceedings for any reason whatsoever under any applicable provisions of law, rules, regulations, bylaws, notifications, directions or order having the force of law for anything done or omitted to be done by the contractor / or his Employees or Agents or Representatives in contravention of such provisions etc. or violation thereof by him or his Employees or Agents or Representatives, in the course of the execution or completion of the work under this contract, and if, as a result of any such action, claim or proceedings, the



Contractor or NBCL, as the case may be is adjudged to be liable to any penalties or to pay any compensation, the same shall be the liability of Contractor and NBCL shall deduct all amount arising out of such liabilities from the security deposit furnished by the contractor or from any other amounts whatsoever due and payable by NBCL to the Contractor under this contract or on any other account and without prejudice to any other rights or remedies available to NBCL in law or otherwise to recover the said amount from the Contractor.

10.0 INCREASE IN SCOPE OF WORK / NEW ITEMS:

- 10.01 On written instructions from NBCL, the Contractor shall perform any additional jobs in connection with the work. The Contractor will have right to represent in writing to NBCL within fourteen days in case of any extra claim for such service. If no such representation in writing is received during the said period, the Contractors right to claim for extra job performed will be deemed to have been waived. - 10.02 Items of work not covered in this tender will be mutually discussed. The decision of NBCL will be final, conclusive and binding on the contractor.

11.0 TERMINATION:
